ENTITLED

AN ACT concerning

Recycling of Home Electronic Devices

FOR the purpose of requiring that home electronic devices be recycled; defining terms; providing the methods of recycling; providing penalties; and generally relating to the recycling of home electronic devices.

By adding

Section 13-4-213.1
Article 13 - Public Health, Safety and the Environment
Title 4 - Solid Waste
Baltimore County Code 2003

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that Section 13-4-213.1 be and it is hereby added to Article 13 - Public
3 Health, Safety and the Environment, Title 4 - Solid Waste, of the Baltimore County Code 2003, to
4 read as follows:
5 §13-3-213.1. RECYCLING OF HOME ELECTRONIC DEVICES.

1 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

2 (2) "HOME ELECTRONIC DEVICE" MEANS A COMPUTER, CPU, COMPUTER
3 PERIPHERALS, INCLUDING A MONITOR, KEYBOARD OR PRINTER, LAPTOP, SCANNER,
4 COMPUTER CABLES AND CORDS, TELEVISION, STEREO, TELEPHONE ANSWERING
5 MACHINE, VIDEO CASSETTE RECORDER, DVD PLAYER, FACSIMILE MACHINE,
6 TELEPHONE, CELL PHONE, VIDEO DISPLAY DEVICE, AND ANY OTHER ELECTRONIC
7 PRODUCT THAT IS SOLD, PRIMARILY FOR PERSONAL USE, TO A HOUSEHOLD BY
8 MEANS OF RETAIL, WHOLESALE OR ELECTRONIC COMMERCE. THE TERM DOES NOT
9 INCLUDE HOUSEHOLD APPLIANCES, SUCH AS CLOTHES WASHERS, CLOTHES
10 DRYERS, REFRIGERATORS, FREEZERS, OVENS, RANGES OR DISHWASHERS.

11 (3) "MANUFACTURER" MEANS A PERSON THAT IS THE BRAND OWNER OF A
12 HOME ELECTRONIC DEVICE THAT IS SOLD OR OFFERED FOR SALE IN THE COUNTY
13 BY RETAIL, WHOLESALE OR ELECTRONIC COMMERCE.

14 (4) "RECYCLING FACILITY" MEANS A FACILITY DESIGNATED BY THE COUNTY
15 FOR THE RECEIPT AND RECYCLING OF HOME ELECTRONIC DEVICES.

16 (5) "RETAILER" MEANS A PERSON WHO SELLS OR LEASES A HOME
17 ELECTRONIC DEVICE TO A HOUSEHOLD BY RETAIL, WHOLESALE OR ELECTRONIC
18 COMMERCE.

19 (B) A PERSON MAY NOT DISPOSE OF A HOME ELECTRONIC DEVICE EXCEPT AS
20 PROVIDED IN THIS SECTION.

21 A PERSON MAY DISPOSE OF A HOME ELECTRONIC DEVICE BY DELIVERING THE
22 DEVICE:

1 (1) TO A RECYCLING FACILITY; OR
2 (2) TO A MANUFACTURER OR RETAILER THAT HAS ESTABLISHED A PROGRAM
3 FOR THE COLLECTION AND RECYCLING OF HOME ELECTRONIC DEVICES.
4 (C) A PERSON WHO DISPOSES OF A HOME ELECTRONIC DEVICE IN VIOLATION OF
5 ~~THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO~~
6 ~~A FINE OF NOT LESS THAN \$500.~~ THIS SECTION IS SUBJECT TO A CIVIL PENALTY OF
7 \$100.

8 SECTION 2. AND BE IT FURTHER ENACTED, that this Act shall take effect forty-five
9 days after its enactment.
