Design Review Areas – Overlea-Rossville Commercial Revitalization District

FOR the purpose of requiring the Design Review Panel to review development plans for proposed nonresidential developments located in certain areas of the Overlea-Rossville Commercial Revitalization District; and generally relating to the review of certain nonresidential development plans by the Design Review Panel.

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, that the Laws of Baltimore County read as follows:

10 (c) A Nonresidential Proposed Development is subject to review under this section if the
11 proposed development is located in any of the following areas that are described by map in the
12 Comprehensive Manual of Development Policies:

13 (1) The Essex Commercial Revitalization District;

14 (2) The Catonsville Commercial Revitalization District;

15 (3) The Arbutus Commercial Revitalization District;

16 (4) The Pikesville Commercial Revitalization District;

17 (5) The Perry Hall Commercial Revitalization District;

18 (6) The Loch Raven-Baynesville section and the Loch Raven-Hillendale section
19 of the Loch Raven Commercial Revitalization District;

20 (7) THE OVERLEA-ROSSVILLE COMMERCIAL REVITALIZATION
21 DISTRICT AREA NORTHEAST OF INTERSTATE 695;

22 [(7)] (8) The South Towson (SOTO) Design Review Area, including review of
23 new construction projects;

1 [(8)] (9) The Historic East Towson Design Review Area;
2 [(9)] (10) The Honeygo Gateway Commercial Revitalization District;
3 [(10)] (11) The Liberty Road Design Review Area; or
4 [(11)] (12) The Dundalk Commercial Revitalization District.

6 SECTION 2. AND BE IT FURTHER ENACTED, that the map showing the area of the
7 Overlea-Rossville Commercial Revitalization District located northeast of Interstate 695 and
8 attached as Exhibit “A,” is hereby adopted by the County Council and shall be added as a Design
9 Review Panel Area to the Comprehensive Manual of Development Policies.

11 SECTION 3. AND BE IT FURTHER ENACTED, that this Act, having been passed by
12 the affirmative vote of five members of the County Council, shall take effect 14 days from the
13 date of its enactment.
