A BILL
ENTITLED

AN ACT concerning

The 2022-2023 Current Expense Budget
Gifts and Grants Special Revenue Fund
Continuum of Care-Planning
McKinney Emergency Shelter Grants

FOR the purpose of amending the 2022-2023 Current Expense Budget, by appropriating to the Gifts and Grants Special Revenue Fund monies derived from federal funds and made available to the County by the U.S. Department of Housing and Urban Development (HUD).

WHEREAS, HUD has made an award of federal funds available to the Baltimore County Department of Housing and Community Development, to be used to assist residents who are experiencing, or who are at risk of, homelessness; and

WHEREAS, HUD has informed Baltimore County of re-directed funding associated with the Continuum of Care program and increased funding for the McKinney Emergency Shelter (Emergency Solutions Grant “ESG”) program; and

WHEREAS, in accordance with Sections 306 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County Code, 2015, as amended, the County Council may accept gifts and grants, appropriate same to the Gifts and Grants Special Revenue Fund and expend the same, said fund having been established solely for the purpose of accounting for certain monetary gifts and grants made available to the County for restricted purposes; and

WHEREAS, such fund remains open perpetually as a mechanism to account for the respective gift and grant appropriations and expenditures throughout the entire term of the grant period, including beyond the current expense budget fiscal year; now therefore

1 SECTION 1. BE IT ENACTED BY THE COUNTY COUNCIL OF BALTIMORE
2 COUNTY, MARYLAND, pursuant to the power and authority conferred upon it by Sections 306
3 and 712(a) of the Baltimore County Charter and Section 10-6-102 of the Baltimore County
4 Code, 2015, as amended, that the Current Expense Budget for the fiscal year ending June 30,
5 2023, be and is hereby amended by appropriating federal funds made available to the Baltimore
6 County Department of Housing and Community Development, in the amount herein specified, to
7 the following program:

9	GR-1107	McKinney Emergency Shelter Grants	\$3,635

10 SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by
11 the affirmative vote of five members of the County Council, shall take effect May 14, 2023.
