AN ACT concerning

Compensation for Boards and Committees

FOR the purpose of providing for compensation for members of the Planning Board, the Police Accountability Board, the Administrative Charging Committee, and Trial Boards; and generally relating to compensation for such Board and Committee members.

9 (b) [A member] THE CHAIR AND MEMBERS of the Planning Board:  
10 (1) May [not] receive compensation [as a member of the Board] AS SPECIFIED  
11 FROM TIME TO TIME IN BALTIMORE COUNTY CODE § 4-6-101; [but] AND  
12 (2) [Is] ARE entitled to reimbursement for expenses necessarily incurred, if  
13 approved by the Board and provided for in the county operating budget.

4 (I) THE CHAIR AND MEMBERS OF THE BOARD:

5 (1) SHALL RECEIVE COMPENSATION AS SPECIFIED FROM TIME TO  
6 TIME IN BALTIMORE COUNTY CODE § 4-6-101; AND

7 (2) ARE ENTITLED TO REIMBURSEMENT FOR EXPENSES  
8 NECESSARILY INCURRED, IF APPROVED BY THE BOARD AND PROVIDED FOR IN  
9 THE COUNTY OPERATING BUDGET.

14 (E) MEMBERS OF THE ADMINISTRATIVE CHARGING COMMITTEE:

15 (1) BEGINNING THE FIRST FULL PAY PERIOD ON OR AFTER JULY 1,  
16 2023, SHALL RECEIVE ANNUAL COMPENSATION AT A MINIMUM OF \$4,000 OR AT  
17 A MAXIMUM OF \$7,500, IN ACCORDANCE WITH THE COUNTY BUDGET, UNLESS  
18 CHANGED BY LEGISLATION; AND

19 (2) ARE ENTITLED TO REIMBURSEMENT FOR EXPENSES  
20 NECESSARILY INCURRED, IF APPROVED BY THE COMMITTEE AND PROVIDED  
21 FOR IN THE COUNTY OPERATING BUDGET.

22 (F) THE CHAIR AND MEMBERS OF A TRIAL BOARD:

23 (1) SHALL RECEIVE COMPENSATION AS SPECIFIED FROM TIME TO

1 TIME IN BALTIMORE COUNTY CODE § 4-6-101; AND

2 (2) ARE ENTITLED TO REIMBURSEMENT FOR EXPENSES  
3 NECESSARILY INCURRED, IF APPROVED BY THE BOARD AND PROVIDED FOR IN  
4 THE COUNTY OPERATING BUDGET.

7 Title 6 – Exempt Service Employees

9 § 4-6-101.

10 (a) Beginning the first full pay period on or after July 1, 2023, the following officers and  
11 employees in the exempt service of the County, and those hired after July 1, 2023, are entitled to  
12 compensation at the pay ranges indicated in the following chart, until changed by County  
13 legislation. Unless a given pay range is indicated as “hourly[,]” OR “DAILY” the range refers to  
14 annual compensation.

Position	Minimum	Maximum
MEMBER, PLANNING BOARD	\$15,000	\$20,000
CHAIR, PLANNING BOARD	\$20,000	\$20,000
MEMBER, POLICE ACCOUNTABILITY BOARD	\$4,000	\$7,500
CHAIR, POLICE ACCOUNTABILITY BOARD	\$7,500	\$7,500
MEMBER, TRIAL BOARD	\$50/DAY	\$50/DAY

1           SECTION 2. AND BE IT FURTHER ENACTED, that this Act, having been passed by  
2 the affirmative vote of five members of the County Council, shall take effect July 3, 2023.

4           SECTION 3. AND BE IT FURTHER ENACTED, that this Act shall be construed to  
5 apply retroactively to July 1, 2023.
