A RESOLUTION of the Baltimore County Council requesting Baltimore County Public Schools (“BCPS”) to ~~begin the review of~~ and evaluate the suitability of land proposed to be dedicated to the County as outlined in Resolution 39-22 ~~as quickly as practicable~~ for use as a vocational school or, in the alternative, an elementary school, middle school, or high school.

WHEREAS, on November 7, 2022, the County Council enacted Resolution 39-22 which approved the continued review of the Planned Unit Development (“PUD”) application from BC Middle River LLC for the redevelopment of a 400.6± acre site out a larger tract of land commonly known as the “LaFarge Quarry;” and

WHEREAS, Resolution 39-22 states that the PUD applicant is to provide a capital improvement benefit in the form of a 221± acre dedication of land in fee to Baltimore County, of which a 40 acre portion is to be utilized for the construction of a vocational school; and

WHEREAS, the PUD Resolution states that should a vocational school not be funded within five years of the conveyance of the land to the County, the Council may choose an alternate use for the 40 acres; and

WHEREAS, the Council recognizes that the County will need the cooperation of the Baltimore County Board of Education on this effort; and

WHEREAS, the recent study completed by BCPS on high school needs failed to include a survey of this location, despite repeated requests to do so, now therefore

BE IT RESOLVED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, that the Council requests BCPS to ~~begin the review of~~ and evaluate the suitability of land proposed to be dedicated to the County as outlined in Resolution 39-22 ~~as quickly as practicable~~ for use as a vocational school or, in the alternative, an elementary school, middle school, or high school, and to provide its findings to the County Council by February 17, 2023; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be sent to the BCPS superintendent and the Board of Education of Baltimore County; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect from the date of its passage by the County Council.
