A RESOLUTION to amend the Baltimore County Water Supply and Sewerage Plan.

WHEREAS, the Planning Board has considered requests for amendments to the Baltimore County Water and Sewerage Plan, and has received recommendations from the Department of Public Works, the Department of Environmental Protection and Sustainability, and the Department of Planning and has reviewed the requested amendments in accordance with the Executive Order concerning the Water and Sewerage Plan Amendment Process dated April 11, 1990; and

WHEREAS, the Planning Board did on July 20, 2023 hold an advertised public hearing on the requests for amendments; and

WHEREAS, the Planning Board by resolution adopted September 7, 2023 recommends that the Plan be amended in the manner set forth herein; now therefore

BE IT RESOLVED BY THE COUNTY COUNCIL OF BALTIMORE COUNTY, MARYLAND, that the Baltimore County Water Supply and Sewerage Plan, as amended, be and it is hereby further amended as follows:

1. The maps attached hereto and made a part hereof marked Exhibit 1 “1021 Carroll Island Road (CP Crane Generating Station)” are hereby approved and areal designations thereof are revised to W-1/S-1 Existing Service Areas for Parcel 155, Parcel 154 (between Parcel 155 and Parcel 141), and Parcel 141 and revised to W-3/S-3 Capital Facilities Area for Parcel 154 (above Parcel 155), Parcel 140 Part 1, and Parcel 140 Part 2 Capital Facilities Area.

BE IT FURTHER RESOLVED, that this Resolution be submitted to the County Executive for his approval; and

BE IT FURTHER RESOLVED, that a copy of this Resolution and attached exhibits be submitted to the Maryland Department of the Environment; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect from the date of its enactment.
