i. Executive Summary

Baltimore County's Implementation of Sewershed Repair, Replacement and Rehabilitation (SRRR) Corrective Action Recommendation Plans are ongoing through the 4th Quarter of 2022 and the County continues completing the corrective action recommendations. This report discusses and documents progress made during the reporting period. In addition to the planning, design and construction of corrective actions contained in the capital projects, the County continues planning and prioritizing operation/maintenance work based on the County's Asset Management model. Below is a summary of Consent Decree project status at the end of Q4 2022.

ii. Introduction

Pursuant to Paragraph 19 of the Consent Decree between the County (County) and the United States Environmental Protection Agency (EPA), the Department of Justice (DOJ), and the Maryland Department of the Environment (MDE), this document constitutes the required Quarterly Report for the period <u>October 1, 2022</u> through <u>December 31, 2022</u>. This Quarterly Report includes historical information, work progress and contracts in place during the reporting period.

This quarterly report documents activities and progress of Baltimore County towards compliance with the requirements set forth in the Consent Decree and documents only activity from the quarter being reported including:

- Construction project status

iii. Non-Pump Station and Pump Station SSO Structure Discharges

Discharges from Sanitary Sewer Overflow Structures took place at the locations and dates during the reporting period as detailed in **Attachment A**.

A summary of flow metering information for Non-Pump Station SSO Structures is included as **Attachment A1.**

iv. Construction Project Status

A summary of all active capital improvement projects that are associated with Baltimore County's Consent Decree is provided in **Attachment B**. The County has completed at least one of the following project status milestone.

v. Collection System Inspection

The County has completed all gravity sewer line inspections required under Paragraphs 8 and 15 of the Consent Decree. The County continues compliance with all gravity line CCTV inspections within the required 10 working days of the occurrence of an overflow for each SSO that occurred during this reporting period. **Attachment C** details the County's inspection response to each of the overflows that occurred during the reporting period.

vi. SRRR Plan Implementation/Progress

The SRRR Plans contain numerous capital improvement projects in a variety of locations and stages of planning, design and construction. A summary of all active capital improvement projects that are associated with Baltimore County's Consent Decree is provided in **Appendix B**. The implementation of the recommended improvement projects is proceeding; however, acquisition of required rights-of-way and regulatory permits may require a significant period of time thereby resulting in possible delays to complete the projects. There have been delays in receiving water and/or sewerage construction permits from MDE.

The County's recommendations in some of the SRRR Plans for meter basins that exhibited excessive I/I and design-storm simulated model-predicted SSOs included the comprehensive rehabilitation of all pipe segments and manholes, increased hydraulic capacity and/or testing and repair of sewer house connections and laterals. Some of the recommended repairs were revised based on design preparation and review of improvement projects. Additionally, some sewer/manhole/lateral repairs that were included in the SRRR Plans may be revised based on a review of the original and updated inspection data. The County is using data from their asset management program to revise the scope of work for some SRRR-related projects.

When reporting on construction projects, the County uses the definition of substantial completion contained in the Consent Decree.

The County has completed implementation of the FOG Program Modification Plan.

ix. Compliance Summary

i) <u>Problems that may prevent the County from meeting future Consent Decree</u> <u>compliance deadlines:</u>

Corsica Pump Station Improvement Project (21162 SX0): The County submitted time of performance extension request on November 22, 2022 and explained in the time extension request and July 11, 2022 potential delay notification that additional time will be required to complete the construction work due to manufacturing delays for the variable frequency drives, which are a critical component of the motor control center unit.



Allowable Exemptions:
